# President's Column

**Practice and Research – and Leadership? – Networks** *James E. Tisdale, Pharm.D., FCCP, BCPS* 

"Never doubt that a small group of thoughtful, committed citizens can change the world. Indeed, it is the only thing that ever has." – Margaret Mead

Substitute the words "practitioners" for" citizens" and "clinical pharmacy practice" for "the world" and you have a perfect description of ACCP's practice and research networks (PRNs). The PRNs were conceptualized and developed in the early 1990s as informal grassroots groups of members sharing a common area of practice or research. During the almost 20 years since they were established, the PRNs have grown in size and number, and their activities have evolved. There are now 22 PRNs, each of which provides important avenues and opportunities for members to interact; develop professional relationships, collaborations, and friendships; contribute important programming to ACCP meetings; and avail themselves of other educational and professional opportunities. Some PRNs have written position statements or guidelines regarding issues of importance for the profession and/or for specific areas of pharmacotherapy. PRN members are recognized as influential pharmacotherapy experts within ACCP, but also at their local institutions, by other pharmacy organizations and by agencies outside the pharmacy profession. Indeed, the PRNs are highly regarded by other pharmacy organizations; a prominent leader from another pharmacy association recently told me that ACCP's PRNs have "set the standard" for networking opportunities within pharmacy organizations and should serve as a model for other associations.

The success of the PRNs is a testament to the dedication and expertise of the PRN membership overall and, in particular, a tribute to the networks' elected leaders and the vision and direction that they have provided. Continued excellence in PRN leadership is crucial to the continued viability of the PRNs and, overall, to the continued vitality of ACCP as a whole. Many members of the Board of Regents and the Research Institute Board of Trustees have initiated



their leadership development through leadership functions within the PRNs. Indeed, most of ACCP's leaders have come either from serving as Chair of one or more ACCP committees and/or from serving as an elected PRN officer. Through the years, and currently, outstanding elected leaders have clearly blessed the PRNs. However, in today's complex and rapidly changing and evolving health care environment, continued excellence in PRN leadership should perhaps not be taken for granted.

How can we ensure that a continuous pipeline of skilled leaders will be available for the PRNs and, by extension, to ACCP overall? I suggest that each PRN devote time to considering strategic methods of cultivating the next generation of PRN leaders. I encourage each PRN to conduct some formalized leadership planning – that is, to consider preparing and implementing formal strategies for continuous development of future leaders for your PRN. There are many ways to achieve this, and the needs of each PRN may be network-specific. Numerous avenues are available within ACCP for leadership training and skills development (through the ACCP Academy's Leadership and Management Certificate Program, for example), through other professional organizations, in published literature, or perhaps through members' own institutions and practices. One suggestion is to consider forming a specific PRN committee or subcommittee that you could charge with preparing recommendations for leadership development within your PRN

The PRNs continue to be the heart and soul of ACCP, and they are routinely cited as one of the important benefits of membership in the College. As you consider strategies for developing and cultivating future leaders for your PRN, please also let members of the Board of Regents know how we can serve you better and meet your needs. # **PRNs to Hold Elections**

The PRN election cycle is upon us. It is time for PRN members to begin the process of determining who will serve as officers in the coming year. If you are interested in being a PRN officer or



in nominating someone, please contact your PRN's Chair.

# **Election Process**

- The Nominations Committee will consist of at least two individuals appointed by the PRN Chair. These individuals may be the PRN's current elected officers.
- Those who comprise a PRN's Nominations Committee will be ineligible to run for office in that PRN's election that year.
- The Nominations Committee should prepare a slate of candidates and shall provide information to each candidate relative to the election procedures, a timeline, and a list of expected duties.
- Whenever possible, two or three candidates for each office shall be up for election. If only one candidate can be identified, an election will still be held, with voters given the option of identifying a write-in candidate. When there are more than three possible candidates, it will be the duty of the PRN's Nominations Committee to make the final selection of candidates for the slate.
- The Nominations Committee will obtain a brief (250 words) biographical sketch or candidate statement from each candidate included on the ballot.

# **Ambulatory Care PRN**

The many committees of the Ambulatory Care PRN have been actively pursuing completion of their charges since last fall. Below is a summary of the work of each committee.

# Advocacy Committee (Chair: Leigh Ann Ross)

The ACCP Ambulatory Care Advocacy Committee worked during 2008–2009 to develop a survey to be administered to the PRN to assess practice sites, billing processes, opinions regarding Medicare provider status, and advocacy practices. This survey has been completed and will be administered in 2010. This year, the Advocacy Committee is also focusing its efforts on creating an overall program (e.g., minisabbatical) for an ACCP member to spend time with the ACCP Government and Professional Affairs team in the



Washington, DC, office to learn more about the advocacy process and professional affairs of ACCP. Committee members will be asked to host or participate in congressional visits at their practice sites. From these experiences, the committee plans to provide a report on the do's and don'ts of hosting an elected official or staff site visit in various settings. We will continue to work with the ACCP Government and Professional Affairs office to facilitate communication to the PRN regarding advocacy issues.

# Budget and Finance Committee (Chair: Edith Nutescu)

The Budget and Finance Committee is working to spend its money for scholarly and productive uses. We are working to increase PRN membership by offering free dues for PGY2 Ambulatory Care residents, to be implemented in July 2010. We have also been working with the Scholarship and Research Committee to evaluate other methods to spend PRN funds, such as continuing the PRN seed grant. The commitment has been made to offer \$1500 to one PRN member to attend the FIT Program. Finally, the PRN will be supporting travel awards for students and residents to the Annual Meeting (i.e., one student and one resident).

# **Communications Committee (Chair: Sarah Westberg)**

The Communications Committee continues to sustain the ongoing tasks of completing the PRN spring and fall newsletters and monitoring the use of the PRN e-mail list. In addition, the committee has several subgroups working on completing the charges. One group is actively working with members of the Scholarship and Research Committee to prepare a poster presentation from its survey results for the 2010 Annual Meeting in the fall. In addition, several committee members are exploring options for a novel means of communication among the PRN members, such as social networking sites. This group will be drawing from the results of the full ACCP member survey completed on this topic. Finally, a subcommittee is reviewing the policies and procedures related to updating the Ambulatory Care Survival Guide and determining the best means to market and sell this guide to individuals outside the Ambulatory Care PRN.

#### Education Committee (Chair: Mitzi Wasik)

The Education Committee is in the process of finalizing the details for programming for the fall 2010 focus session at the Annual Meeting in Austin, Texas. The session will focus on Updates in Antithrombotic Therapy. The committee will explore possible opportunities for collaborating with another PRN to develop focus session programming for the future.

#### Networking Committee (Chair: Daniel Riche)

The Ambulatory Care PRN Business Meeting and Networking Forum at the ACCP Spring Research and Networking Forum in Charlotte, North Carolina, has been scheduled for Saturday, April 24, at 12:30 p.m. Although there is no entertainment because of meeting time constraints, the committee has set up the education for this event. The committee assignments are set for implementing "walk rounds" at the Annual Meeting. During the spring/ summer, the committee will set up the education and entertainment for the Annual Meeting. In addition, the committee will solicit and review nominations for the annual PRN Member Achievement Award.

#### Nominations Committee (Chair: Alan Zillich)

The Nominations Committee is charged with helping identify PRN members for ACCP awards, elected offices, and fellowship status. We are also responsible for seeking nominations for PRN offices and putting forth the slate of candidates. On March 1, we put out a call for Ambulatory Care PRN officer positions for 2010–2011. This year, we will elect a Chair-Elect (1-year term to be followed by 1 year as PRN Chair) and Treasurer (2-year term). We would like to encourage those who are interested in nominating someone or themselves to e-mail any member of the committee no later than May 1, 2010. Also in May, look for a call for nominations for the Ambulatory Care PRN Achievement Award. Last year, Stuart Haines received this award.

# Scholarship and Research Committee (Chair: Daniel Longyhore)

The 2009–2010 Scholarship and Research Committee (SRC) was active in completing several charges that included compiling the results of the "Diversity and Needs Survey," ranking and funding two PRN seed grant applicants, and developing a funding line to partially fund an Ambulatory Care PRN member to the 2011 FIT Program offered by ACCP's Research Institute.

The "Diversity and Needs Survey" was conducted, and results were compared with data from the 2003 survey. The data are being organized and will be presented jointly at the ACCP Fall 2010 Meeting in conjunction with the Communications Committee. Research-specific needs scored low on this, and a focused survey on research needs is under development for 2010 to better understand how the PRN or ACCP can support this need of its members.

The SRC began publicizing the seed grant in July 2009 and received six strong applications to deliberate on. In the end, committee members agreed to partially fund two applications from Whitney Maxwell and Amy Kennedy. Two thousand dollars has been allotted from the Budget and Finance Committee for the 2010–2011 grants, and notice for new applications will take place in summer 2010. The SRC will then review, rank, and fund as indicated, with an announcement of recipients made in late fall 2010.

The SRC worked closely with the Budget and Finance Committee in 2009 to explore funding opportunities for the FIT Program offered by ACCP's Research Institute, and they agreed to contribute 50% of the tuition (\$1625) toward the funding of one PRN member. The SRC will develop an application form in 2010 and make it available to members by the time of the Annual Meeting in the fall.

**Resident and Student Committee (Chair: Kim Thrasher)** This committee has identified Kelly Lempicki and Christie Schumacher to serve as StuNet liaisons. A subcommittee is actively working on developing activities for the Annual Meeting for residents and students. The committee is working closely with the Budget and Finance Committee to develop a plan to communicate the free dues initiatives to residents and to develop a plan to sponsor a student/resident travel award. Finally, this committee will be prioritizing a plan for the annual activities of this relatively new committee.

# Nephrology PRN

# **PRN** Activities

In November 2009, the Nephrology PRN submitted comments to the Centers for Medicare & Medicaid Services (CMS) in response to the proposed rule, "Medicare Programs; End Stage Renal Disease (ESRD) Prospective Payment System" (also referred to as "bundling" of payments). Under this legislation, many services related to dialysis treatment would be bundled into one payment for reimbursement. The dialysis center would be reimbursed a fixed fee for all dialysis equipment, laboratory fees, and dialysis-related medications. In addition, the definition of a "dialysis-related" drug would be expanded to include not only injectable agents such as erythropoiesis-stimulating agents and iron products, but also oral, "home medications" such as phosphate-binding agents and calcimimetics. The allotted reimbursement for medications (around \$15 per treatment) would likely not meet the needs of many patients, and many members raised concerns. Dr. Wendy St. Peter compiled our comments and evidence into a cohesive document and petitioned CMS to reconsider many components of the proposal, positing,

We understand that bundling of payments for dialysis services is designed to reduce financial incentives for utilization of unnecessary dialysis services. However, we believe that the current proposed bundle will lead to unintended consequences including under treatment of certain vulnerable ESRD patients and further fragmentation of medication management in these patients. We are also concerned that bundling could stifle innovation in new medication therapies for ESRD patients and, thereby, reduce the likelihood of further improvement in patient care.

The Winnipeg Regional Health Authority's Manitoba Renal Program received the 2009 Commitment to Care Award. Their initiative to increase the number of pharmacists providing direct patient care to patients with chronic kidney disease began in 1998. Their vision was to increase the pharmacy team (then 1.5 clinical pharmacists) using a unique, population-based funding structure. They have achieved their goal, increasing the team to 10 fulltime equivalents (FTEs). In fact, their funding model for a fixed ratio of pharmacists to patients is now included in the planning process for every new dialysis unit, ensuring positions for clinical pharmacists and optimal pharmaceutical care for all patients in this setting. In addition to direct patient care, this program has allowed the clinical pharmacy team to demonstrate its value in providing training and education to pharmacy students as well as to other health professionals. Member of this team are also able to participate in research projects to improve medication use and have generated millions of dollars in drug-related cost savings. Their unique funding structure has definitely proved its worth!

The Nephrology PRN is currently writing a PRN Opinion Paper titled **"Using Cockcroft-Gault and Modification of Diet in Renal Disease Equations to Dose Medications."** This paper will provide information and evidence pertinent to the controversy and debate that surround the issue of assessing kidney function and determining optimal drug doses in patients with chronic kidney disease. The final draft of the paper will be presented during the Nephrology PRN Networking and Business Meeting at the ACCP Spring Practice and Research Forum in Charlotte, North Carolina. We have applied for a focus session at the ACCP Annual Meeting in Austin, Texas, in October 2010 to present this debate in more detail.

# Advocacy Update

# Health Care Reform Update, Spring 2010

If the battle over health care reform taught us anything, it is, "never try to predict the future." Throughout 2009, informal

deadlines to pass legislation slipped from the August recess to Thanksgiving, then Christmas, and then to the President's State of the Union address in January.

Massachusetts, the commonwealth that has consistently elected Democratic heavyweights from Ted Kennedy to Tip O'Neill, from John Kerry to Barney Frank, surprised everyone apart from perhaps the charismatic candidate himself when voters sent Republican Scott Brown to the U.S. Senate.

Yet, despite the President's plummeting approval ratings, the loss of the 60-seat supermajority in the Senate, and the overall perception of the Democrats as a party in disarray, President Obama signed a landmark health care reform package into law on March 23, 2010.

The new law, known as The Patient Protection and Affordable Care Act (PL 111-148), recognizes among its many critical reform provisions the medication use problems our country faces and provides support for expanding and supporting the role of the clinical pharmacist in addressing these problems. The law also delivers a series of health care delivery reforms to promote coordination among health care providers and several important changes to the Medicare Part D MTM benefit.

# **Clinical Pharmacy Services**

Specific to clinical pharmacy services, the law provides for:

**MTM Grant Programs:** The new law establishes a standalone grant program to provide pharmacist-provided MTM services as defined by the pharmacy profession's consensus definition on the Core Elements of an MTM Program. The program ensures testing of practice and care delivery models, such as patient-centered self-management programs, that improve patient outcomes through team-based collaboration between prescribers and pharmacists.

**Integrated Care Models:** The law also includes provisions to ensure that providers with expertise in pharmacotherapy, including pharmacists, are fully engaged in integrated, collaborative, team-based approaches to delivering care, including medical homes, accountable care organizations, community health teams, and home-based chronic care programs.

**Transitional Care Activities:** The law recognizes the gaps in care coordination and communication that often occur when patients are transferred from one setting of care to another. Problems arising from inappropriate medication use are a primary reason for hospital readmissions. Pharmacists, helping to manage pharmacotherapy as part of a transitional care team, will be able to play major roles in preventing these events. Transitional care activities might include medication reconciliation, improved use of personal medication records, and discharge planning that may include MTM services. Medicare Advantage Plan Incentives: The law provides bonus payments to Medicare Advantage plans that conduct care coordination and management activities. In particular, it acknowledges the need for MTM programs to address medication use issues such as poly-pharmacy through medication reconciliation, periodic reviews of drug regimens, and integration of medical and pharmacy care for chronically ill, high-cost beneficiaries.

**Workforce:** The law establishes a National Health Care Workforce Commission that will study health care workforce supply issues and make recommendations back to Congress.

#### Next Steps

The inclusion of these provisions in the final law represents a formal recognition at the federal level that MTM is a vital component of the nation's health care reform initiative and a recognition of pharmacists as health professionals uniquely qualified to deliver these services as members of the health care team.

This recognition is the result of an ongoing, professionwide effort to educate lawmakers, advocate for expanded access to pharmacists' services, and draw attention to the issue of medication use.

Even before the bill was signed into law, ACCP and our pharmacy stakeholder colleagues had initiated discussions with key leaders in Congress and the administration regarding the scope and structure of the clinical pharmacy provisions outlined in the legislation.

These discussions included meetings with congressional appropriators, who ultimately determine the funding of the provisions; outreach to the administration officials in Health and Human Services (HHS) agencies who will administer the programs; and ongoing participation in the Patient-Centered Primary Care Collaborative (PCPCC). PCPCC is a coalition of more than 500 major employers, consumer groups, patient quality organizations, health plans, labor unions, hospitals, and clinicians who have joined together to develop and advance the patient-centered medical home (PCMH). PCPCC is considered the primary work group for the development of the PCMH.

# How You Can Get Involved

ACCP's <u>Legislative Action Center</u> contains a wealth of information about your elected officials and allows you to communicate with your members of Congress.

Remember, to maximize your impact, you are encouraged to edit and personalize the letter, providing background on your practice and professional experience.

In addition, you are strongly encouraged to make the following requests in your letter:

- Ask for a list of the dates your members of Congress will be available for meetings in their district or state.
- Ask about any "Town Hall" meetings your members of Congress have scheduled, particularly those focused on health issues.
- Request an in-person meeting with your members of Congress and/or staff while they are home for the recess.

#### Invite your legislators to tour your practice setting

Perhaps the single greatest challenge facing the pharmacy community in Washington is the enduring perception that





pharmacists are drug dispensers who do not play a role in patient care. The most effective step an ACCP member can take to help members of Congress understand the differences between traditional retail pharmacy and the patient care services provided by a clinical pharmacy is to invite members to tour a practice setting and to see firsthand what clinical pharmacy is all about.

ACCP has prepared a guide to help you reach out to members of Congress and schedule a visit. We have even drafted a letter you can send directly from the Legislative Action Center inviting your federal officials to tour your facility.

# ACCP Political Action Committee (PAC)

ACCP's 2007 Strategic Plan called for an examination of the feasibility and value of establishing an ACCP Political Action Committee (PAC).

Based on research conducted by staff and outreach to ACCP membership, the ACCP Board of Regents at its February 2010 meeting approved the establishment of a PAC to support and advance ACCP's advocacy agenda in Washington, DC.

# What is a Political Action Committee (PAC)?

- A PAC is a legally defined entity organized to help elect political candidates.
- PACs must report all financial activities, including direct donations and other expenses, to the Federal Election Commission (FEC), which makes the reports available to the public.

# Why Establish a PAC?

- A PAC is the only means by which ACCP can provide financial support to help elect pro-pharmacy candidates.
- Political contributions help raise our profile in Washington, DC.
- Attending fundraising events offers an opportunity to secure face time with members of Congress or congressional staff.
- ACCP members can also attend events on behalf of the College and help improve their relationships with elected officials.

# Why Support Your PAC?

The success of the ACCP PAC depends entirely on the support of ACCP members. Although we recognize the

commitment that ACCP members already make to the College and other professional organizations, this is clinical pharmacy's PAC, which presents a unique opportunity to raise our political profile and advance our advocacy agenda.

ACCP will roll out a newly launched PAC during the coming months. Watch for further updates on how you can get involved in this exciting venture.

# ACCP/ASHP/VCU Pharmacy Policy Fellow Program

In 2006, ACCP, together with the Virginia Commonwealth University (VCU) School of Pharmacy and the American Society of Health-System Pharmacists (ASHP), established the country's first Pharmacy Healthcare Policy Fellow program.

Under the leadership of Gary R. Matzke, Pharm.D., of the VCU School of Pharmacy, Ed Webb, Pharm.D., MPH, of ACCP, and Brian Meyer of ASHP, the program was developed to provide active learning in multiple policy environments.

The initial month of the program consists of an orientation curriculum put on by faculty of the VCU School of Pharmacy and the government affairs staff of ACCP and ASHP. Fellows then spend 1 year working as special assistants/fellows on the staff of a congressional committee or the personal staff of a U.S. senator or representative.

The program provides a unique health care policy learning experience that allows the Fellow to make practical contributions to the effective use of scientific and pharmaceutical knowledge in government decision-making.

The Fellow will be actively mentored during his/her development of legislative evaluation and policy development skills as well as research and writing skills as he or she integrates practical policy experience with theory.

The Fellow will also be expected to undertake a wide array of responsibilities in the congressional office he or she serves, including researching and writing briefs on health care issues, assisting with policy decisions, drafting memoranda, and planning, organizing, and contributing to the management objectives of the office.

# Introducing the Pharmacy Healthcare Policy Fellows

**2006–2007:** The program's inaugural fellow – George Neyarapally, Pharm.D., MPH – worked in the Office of the Assistant Secretary for Preparedness and Response (ASPR) within the Department of Health and Human Services (HHS) for 6 months, followed by almost 6 months in the office of Senator Joseph I. Lieberman (Independent-Connecticut).

Dr. Neyarapally went on to be a policy scientist in Pharmaceutical Outcomes Research in the Center for Outcomes and Evidence at the Agency for Healthcare Research and Quality (AHRQ) and is currently a pharmacist at the Office of Surveillance and Epidemiology (OSE) within the Center for Drug Evaluation and Research (CDER) at the U.S. Food and Drug Administration (FDA).

**2007–2008:** Our second Pharmacy Healthcare Policy Fellow - Anna Legreid Dopp, Pharm.D. - took leave from her position as a Clinical Assistant Professor at the University of Wisconsin School of Pharmacy to move with her husband and dog to Washington, DC.
