

Adult Medicine Emerging PRN Member Award

To recognize excellence in adult medicine pharmacy clinical practice, research, and service to the PRN by an active member of the ACCP Adult Medicine PRN in the early stages of their pharmacy career.

Eligibility Criteria

The Nominee should:

- Be an ACCP member in good standing
- Be an Adult Medicine PRN member in good standing for at least two consecutive years
- Have completed their terminal pharmacy degree within the past 10 years
- Must have established a current practice as a clinician in adult medicine pharmacotherapy or researcher in an adult medicine related area of pharmacotherapy
- Served as a lead author on at least one peer-reviewed publication or co-author of at least three peer-reviewed publications
- Must have been actively involved in the Adult Medicine PRN by at least one of the following:
 - 1) serving on two separate standing committees
 - 2) serving as a committee Chair or Vice-Chair
 - 3) serving as a PRN officer

Nomination Submission Requirements:

- Nominations may be made to the committee chair on an ad hoc basis or by submitting a letter of recommendation (see below). Individuals are able to self-nominate, but will need to have two letters of recommendation as stated below.
- Updated curriculum vitae
- A one page document highlighting the following:
 - o Funding and publication record in research with a brief description of the nominee's role
 - o List of leadership, committee involvement, and other volunteer duties within the AMED PRN and/or ACCP
- Two letters of recommendation which clearly document the nominee's contributions to the profession of pharmacy, research, service and any additional information that distinguishes the nominee. Both letters are not required at the time of nomination. A maximum of two letters of recommendation will be reviewed by the committee. At least one of the letters must be from an Adult Medicine PRN member. Letters of recommendation from non-ACCP members (i.e. colleagues, supervisors, other health care providers) attesting to the performance of the nominee are welcomed, but only one of the two letters of recommendation may come from the institution of the nominee's current employment.
- Submissions that do not receive the award will be maintained for one year and reconsidered the following year if the nominee remains eligible.

This Awards Includes:

\$200 honorarium and recognition with plaque at Adult Medicine PRN business meeting at the Annual ACCP Meeting

Tentative Timeline:

- June: Announcement of awards being available to PRN
- August 3: Submission deadline nomination materials
- August: Choose award winner and inform winners of award recognition
- October: Recognize award winners at Adult Medicine PRN business meeting

All nomination materials should be submitted via email to the Chair of the Nominations Committee by August 3rd of each year. If this date is Saturday or Sunday, the nomination is due on the following Monday by 11:59 pm EST.
